Key Stage 4

Key Stage 4 provision for Years 10 and 11 students is currently 4 or 5 x 1 hour lessons per 2-week cycle, depending on the ability group. We follow the Edexcel examination board syllabus: both year groups complete the Level 2 First Award or Certificate in Health and Social Care.

Key Stage 5

At Key Stage 5, both the Level 3 Subsidiary (single) and Diploma (double) programmes are delivered. Assessment is on-going, with students on the Diploma programme undertaking 100 hours (3 weeks) of work-placement, in a range of H&SC settings, over the 2 years of study. There are currently no external examinations at Key Stage 5. All assessment is undertaken internally, through the production of 12 portfolios: then, a random sample of 2 units will be requested for external verification by Edexcel.
