- To ensure compliance with relevant legislation, Trust policies, procedures and guidance.

- 1. To support the process of self-evaluation and compliance activities and carry out internal compliance checks to ensure that academies are working to Trust policies, procedures and practices, including statutory requirements;
- 2. To monitor and analyse academy self-assessment against Trust expectations and to identify areas of non-compliance;
- 3. To recommend corrective actions and service improvements.
- To liaise with the Finance Team regarding internal audit as required, ensuring that any recommendations for specific academies are implemented in all Trust academies;
- 5. Produce reports and data for Trust Leaders, Directors & Governors demonstrating that statutory and Trust expectations are being met;
- 6. To support the Governance Manager in the coordination of responses to both Subject Access Request under Data Protection Act 2018 and Freedom of Information and in conducting/reviewing information asset audits;
