Purpose of the role (job statement)

The Faculty Leader should be an exemplar of both leadership and teaching skills and lead the improvement of curriculum design and implementation across the faculty through effective support, monitoring and evaluation of colleagues.

The Faculty Leaders will work to develop both the strategic vision for Design and Technology across the school alongside a clear plan on how this can be successfully implemented and monitored.

Main purpose of the job:

- To uphold the vision and aims of the school.
- To work cooperatively with, and in support of, all adults in the school.
- To work with students in a courteous, caring and responsible manner at all times.
- To work with visitors to the school in such a way that it enhances the reputation of the school. To present oneself in an appropriate manner so that it upholds the values of the school.
- To raise standards of student achievement within the whole curriculum area (KS3, 4 and 5) and to monitor, support and ensure student progress.
- To develop and enhance the teaching practice of others within the faculty to ensure outstanding teaching and learning.
- To ensure the provision of an appropriately broad balanced, relevant and appropriately differentiated curriculum is available for students in technology.
- To be accountable for student progress, attainment and development of KS3, KS4 and KS5 within the faculty, including extra-curricular provision.
- To be accountable for leading, managing and developing the curriculum area and extra curricular activities.
- To effectively manage and deploy teaching and support staff. To effectively manage financial and physical resources within the faculty.

Main Duties and Responsibilities: -

Duties and responsibilities in addition to the responsibilities of Class Teacher, as set out by the Class Teacher job description and the school teachers' pay and conditions document, the holder of this post is expected to carry out the professional duties described below, as circumstances may require and in accordance with the school's policies under the direction of the Headteacher

Leadership

- Responsibility for the quality of teaching and learning in the curriculum area.
- Monitoring staff performance.
- Development of effective teaching and learning styles/strategies within the faculty.
- To draw up faculty improvement plans which mirror the whole school improvement plan.



- To ensure faculty is meeting whole school plans/initiatives.
- To keep SLT informed re: performance of the faculty and its staff.
- To organise and lead faculty meetings.
- To represent the faculty at Curriculum Leaders' meetings.
- To lead whole school developments alongside SLT.
- To provide regular feedback to SLT re: pupil performance/achievement and progress towards targets. Have effective strategies in place to ensure pupils meet targets and achieve in line with their abilities.
- Motivate, support, challenge and inspire colleagues to provide outstanding provision for our pupils, leading to outstanding outcomes.
- Use quality assurance methods to ensure all work associated with the role has the desired impact.
- Develop a coherent, shared vision for learning through teamwork, collaboration and sharing of best practice, ensuring a consistent approach to teaching.
- Seek out best practice through networks and research, to share with colleagues
- To ensure high standards of student behaviour in subject lessons, supporting colleagues.
- To implement School Policies and Procedures, eg Equal Opportunities, Health and Safety, COSHH etc.
- To ensure that Health and Safety policies and practices including risk assessments throughout the faculty are in line with national requirements and are updated where necessary, therefore liaising with the school's Health and Safety Manager.

Professional development of colleagues

- Promote a culture of collaborative working within the Technology faculty
- Maintain and awareness of new initiatives and national developments in education
- Develop outstanding teaching and learning across the faculty and promote a culture of sharing good practice.
- Review examination courses offered to students annually.
- Ensure continual professional development of faculty staff.
- Accountability for the performance management of faculty staff.
- Liaise with partner primaries to ensure effective transition and progression from KS2 KS3.
- Prepare and run professional development courses for staff
- Design programmes of support for individuals as and when required
- Support colleagues in developing strategies to deepen learning for able pupils and vulnerable pupils.
- Keep colleagues up to date with developments in best practice identified through networks and research

Professional development of self

- Be proactive in seeking out networks and research in order to identify best practice and latest developments
- Develop coaching skills and abilities

Supporting pupil attainment and achievement

 Support or lead strategies for accelerating the progress for all pupils and for particular individuals or groups of underachieving pupils with a focus on disadvantaged students..



- To use local and national statistical data and other information to provide a comparative baseline for evaluating learners' progress and attainment as a means of judging the effectiveness of the interventions or strategies and as a basis for improving teaching and learning.
- To monitor and assess the effectiveness of learning activities and provide timely and constructive feedback to support pupils' learning.
- Use data analysis to identify trends in attainment and to identify individuals/groups that are under attaining or are at risk of doing so. Identify patterns of attainment.

Quality Assurance

- Monitor the quality of teaching and learning across the Technology Faculty through lesson observations and the scrutiny of students' work.
- Review colleagues' planning and provide effective feedback to inform professional dialogue.
- Actively promote a culture of sharing 'good practice' across the Faculty.
- Evaluate schemes of work to ensure they focus on consistently high quality first teaching and learning and effective assessment of student progress.
- Actively promote independent learning across the Technology Faculty.
- Establish effective coaching and mentoring within the faculty
- To help implement college quality procedures and to adhere to those.
- To contribute to the process of college self-review in line with agreed college procedures, including evaluation against quality standards and performance criteria.
- To seek/implement modification and improvement where required.

Other Specific Duties

- To support the college in meeting its legal requirements for worship.
- To actively promote the college's corporate policies.
- To continue your own personal development as agreed.
- To comply with the college's Health and Safety policy and undertake risk assessments as appropriate, including in relation to visits off-site.
- To undertake supervisory duties as outlined in the annual schedule.
- To organise for appropriate work to be done by students for known absences from duty.
- To undertake any other duty specified by STPCD not mentioned in the above.
